- 1. Member introductions and updates-** Thank you to everyone that was able to join the meeting. Members provided the following updates:
 - **Leah** – The Tobacco Control/Prevention grant is extended through June 2021. WellSpan launched Media Campaign about COVID-19 and Tobacco use. Cessation programs are continuing virtually.
 - **Bob** – Community Narcan distribution events took place in many areas including Littlestown, Biglerville and Gettysburg.
 - **Lauren** – Community Care Behavioral Health is keeping providers updated and providing payment arrangements. The adult Family advisory meetings are currently taking place, and the next meeting is February 4th. The speaker will be from York County Food Bank.
 - **Lorna** – Lactation Consultant, RN and works with new Mothers, and talks with her new moms about Tobacco. Smoking at work is a common topic that comes up frequently, and she is interested in sharing continued resources from this coalition.
 - **Sarah** – The classes and programs are continuing and there has been an increase in interest in resources.
 - **Adam**- The UPMC Tobacco treatment team continues to work closely implementing changes in programming from in person to virtual, also addressing healthier ways to manage stress during COVID-19.
 - **Kelly** – Manager, Outpatient Pulmonary services WellSpan Health. There is a new NRT protocol for the Hospital, and currently referring patients to Tobacco cessation.
 - **Pam** – Tobacco cessation programs via phone and virtual platforms in place. Three nicotine support groups – including one virtual, and two Facebook groups. Email- Millerpa4@upmc.edu if interested.
- 2. October meeting recap**
 - Members provided current updates with their organizations, and the focus was updating the website and revising the worksite letter to reflect changes with COVID-19.
- 3. TFYC website review**
 - The website page was shared virtually by Leah and suggestions were made as what sections need updates. There will be a separate subcommittee to continue to work on the website. Recommended changes include:
 - Mentioning classes that are happening virtually
 - Rearranging “current initiatives” to reflect what we are working on now
